#### **About the 2019 California Opioid Care Honor Roll Program**

#### **Background**

Every day, more than 130 people in the United States die after overdosing on opioids. The misuse of and addiction to opioids—including prescription pain relievers, heroin, and synthetic opioids such as fentanyl—is a serious national crisis. In California there were over 2,000 opioid overdose deaths in 2018, a 5 percent increase from the prior year, including over 700 deaths from fentanyl, a 72 percent increase.<sup>2</sup>

Hospitalization is a "reachable moment" for many people with opioid use disorder (OUD).<sup>3</sup> To accelerate hospital progress in building systems to treat hospitalized patients with OUD and train health care professionals in opioid safety practices, Cal Hospital Compare supports the California Opioid Care Honor Roll Program. The goal of the program is increased access to addiction treatment for hospitalized patients and reduction of opioid-related deaths.

- All California adult, acute care hospitals were invited to participate in this pilot year of the Program, and 60 hospitals voluntarily submitted data sharing their progress on implementing evidence-based practices to address the opioid crisis.
- Participating hospitals answered nine questions across four key domains of care including preventing new opioid starts, identifying and managing patients with Opioid Use Disorder, preventing harm in high-risk patients, and applying cross-cutting organizational strategies that were developed by a multi-disciplinary workgroup of addiction experts, policymakers, measurement scientists, and hospitals.
- To help accelerate implementation of best practices Cal Hospital Compare offered a 5-part, webinar series with subject matter experts and representatives from peer hospitals that have successfully deployed best practices. These webinars are available on the <u>Cal Hospital</u> <u>Compare website</u>. The <u>California Bridge Program</u> also offers free training.
- We learned important lessons during the pilot year, including:
  - Several hospitals are advanced in implementing practices to address the opioid epidemic; others are just starting.
  - Many hospitals have implemented prescribing practices that reduce the use of opioids for patients who visit emergency rooms, new patients with pain, and patients being discharged to reduce the likelihood of chronic use.
  - A much smaller group of hospitals has implemented harm reduction programs using naloxone, an opioid overdose reversal agent. This is a statewide opportunity for improvement.



### **About the 2019 California Opioid Care Honor Roll Program**

- In 2020, Cal Hospital Compare will update the opioid care program with additional practices that are proven effective and will support their rapid spread among hospitals with additional learning opportunities, including another webinar series.
- o In 2020, Cal Hospital Compare will announce the first Opioid Care Honor Roll. All California adult, acute care hospitals are invited to participate.
